

# Collection Notice Statement

**Wee Hur Hospitality Pte Ltd (Reg No 201943047E)** and its related bodies corporate (**Y Suites**) are committed to protecting the privacy of individuals and their personal information or personal data (as defined in the Privacy Act 1988 (Cth) (Australian Privacy Act), together the Privacy Law, in respect of individuals within Australia, as the case may be) or personal data (as defined in the General Data Protection Regulation (GDPR) in respect of individuals in the EU).

Please read this carefully as it will have important consequences for you in relation to the collection, use and disclosure of your personal information or personal data provided to **Y Suites**.

You understand that:

1. **Y Suites** is the party who is collecting your personal information or personal data. You can contact us by email at [reservations@ysuites.co](mailto:reservations@ysuites.co), or alternatively you can write to us at 128 Waymouth Street, Adelaide, SA 5000.
2. The purposes of **Y Suites** collecting your personal information or personal data includes but is not limited to:
  - a. verifying your details, and enrolment at an eligible University;
  - b. processing your application for enrolment at a **Y Suites**' residence;
  - c. providing you with accommodation, and all of the related support and services that **Y Suites** offers to residents;
  - d. assisting you in the case of any injury or emergency in connection with us or that occurs on **Y Suites**' premises; and
  - e. to exercise **Y Suites**' duty of care to you when you are on its premises and assist with your rehabilitation;
  - f. processing any payments in connection with your enrolment at a **Y Suites**' residence;
  - g. providing you with marketing materials concerning upcoming events **Y Suites** thinks may be of interest to you;
  - h. ensuring your safety when on **Y Suites**' premises and verifying any instances of breach of its rules, the applicable law or complaints by way of video recording and image capture,

and you agree to your personal information or personal data being collected and used for, and in connection with, these purposes and any other purpose in **Y Suites**' Privacy Policy.

3. In some instances, we may collect personal information or personal data from your alternative contact (such as your parent or guardian). You acknowledge that your alternative contact is aware that **Y Suites** holds their information for the purposes of exercising its duty of care to you.
4. In some instances **Y Suites** may collect personal information or personal data from you which is unsolicited. To the extent reasonable, **Y Suites** will delete or de-identify any unsolicited personal information. However, due to the nature of **Y Suites**' IT system, if you use **Y Suites**' IT system to send or receive personal emails **Y Suites**' will be unable to remove any personal information or personal data which is backed up and stored on **Y Suites**' servers. You acknowledge and you agree to your personal information or personal data being collected and stored by **Y Suites**.
5. If **Y Suites** does not collect this personal information or personal data in connection with the purposes in paragraph 2, it may not be able to assist you with your application to reside at a **Y Suites** premises.
6. Your personal information or personal data being disclosed to the following classes of people and organisations for the purposes in paragraph 2:
  - a. **Y Suites**, its personnel and related entities;
  - b. your financial institution and **Y Suites**' financial institution;
  - c. third party service providers (such as event co-ordination and hire, IT suppliers);
  - d. medical or health service providers that are required to assist you in the case of an emergency;
  - e. third parties who assist with the marketing process and any other organisation set out in **Y Suites**' Privacy Policy.
7. It is possible that some of the information collected for the purpose of your residence at **Y Suites**' premises may be disclosed to **Y Suites**' related bodies corporate or service providers outside of Australia, as the case may be. You consent to your information being disclosed to a destination outside Australia for this purpose, and you understand and acknowledge that either the Australian Privacy Principle 8 will not apply to such disclosures of your personal information or personal data outside of the relevant jurisdiction.
8. **Y Suites**' Privacy Policy sets out the process as to how you can access and correct any of your

personal information collected for the purposes outlined in paragraph 2, as well as to how you can make a complaint if **Y Suites** has breached the Privacy Law in the handling of your personal information. **Y Suites'** Privacy Policy is available at <https://www.ysuites.co>.

#### **Additional information for residents of the European Union**

If you are a resident of the European Union and we collect personal data from you, the following additional information applies to you:

9. **Y Suites** is a “data controller” (as defined in the GDPR) and is responsible for processing your personal data in relation to your residency application and (if successful) your tenancy in **Y Suites'** premises in Australia.
10. We will store your personal data collected in accordance with this statement until the expiry of 12 months from the date of termination of your residency with us.
11. We may transfer your personal data to our related entities in Australia, and this transfer is protected by contractual obligations between **Y Suites** and each of these entities safeguarding the security of your personal data.
12. Under the GDPR, you are entitled to:
  - a. (Access) request access to your personal data held by **Y Suites**;
  - b. (Rectification) request to update or rectify any of the personal data that **Y Suites** holds about you by contacting us at the details specified above and request personal data updates;
  - c. (Erasure) request that we erase your personal data that **Y Suites** holds, where that data is no longer required for the purpose for which it was collected;
  - d. (Restriction on processing) obtain from **Y Suites** a restriction on processing of your personal data where:
    - i. the accuracy of the personal data is contested;
    - ii. the processing by **Y Suites** of the personal data is unlawful (and you oppose erasure but request restriction of use);
    - iii. **Y Suites** no longer needs your personal data; or
    - iv. you have objected to processing pursuant to your right to object under Article 21(1) of the GDPR;
  - e. (Data portability) request that **Y Suites**:
    - i. provides you with a copy of the personal data that **Y Suites** holds about you in a portable and machine readable form; or
    - ii. share your personal data with a nominated third party.
13. **Y Suites** does not engage in any automated decision-making (such as profiling) in respect of your personal data.
14. If you have any concerns in relation to **Y Suites'** collection or processing of your personal data pursuant to this statement, then you also have a right to complain to the data protection authority [https://ec.europa.eu/newsroom/article29/item-detail.cfm?item\\_id=612080](https://ec.europa.eu/newsroom/article29/item-detail.cfm?item_id=612080) in your EU country (within the meaning of the GDPR).
